## **Privacy Policy**

## **Data Protection**

We implement the following measures to protect your data:

- Encryption: We use encryption to protect your data
- Secure storage: Data is stored on secure servers with access controls.

## Legal Basis for Processing your Data

Under the General Data Protection Regulation (GDPR), we must have a legal basis to process your personal data. The six possible legal grounds for processing are:

- 1. Consent: We may process your personal data if you have given clear consent for us to do so. You can withdraw your consent at any time by contacting us.
- 2. Contract: Processing is necessary for the performance of a contract with you, or to take steps at your request before entering into a contract. This includes processing your data to provide the services you have requested.

- 3. Legitimate Interests: We may process your data if it is necessary for our legitimate interests, provided these interests are not overridden by your rights and interests. Our legitimate interests include improving our services, enhancing user experience, and ensuring the security of our systems. We will always balance our interests against your rights to ensure fair processing.
- 4. Vital Interests: Processing may be necessary to protect your vital interests or those of another person.
- 5. Public Task: Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in us. This applies mainly to public authorities and organisations performing tasks in the public interest.
- 6. Legal Obligation: We may process your personal data to comply with a legal obligation. This includes processing data for legal reporting requirements or to comply with court orders.

We collect data for the purposes outlined above. We ensure that data is either erased from our system when it is no longer needed for its original purpose, retained for legal reasons, or minimised and retained as necessary. Any health data collected from you is subject to special protection and is limited to what is permissible by law.
